

The George E. & Susan E. Schiereck Grimm Council Circle

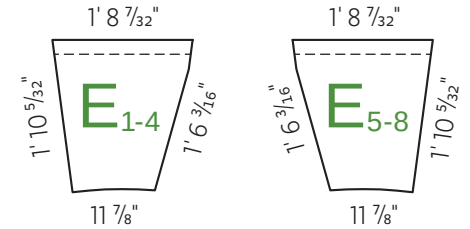
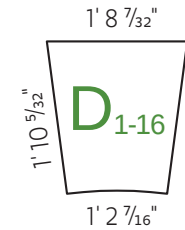
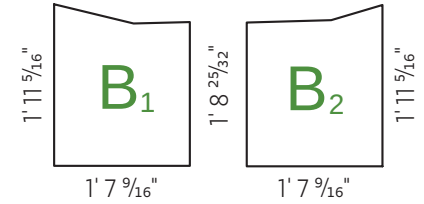
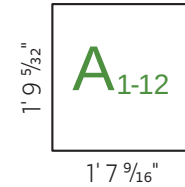
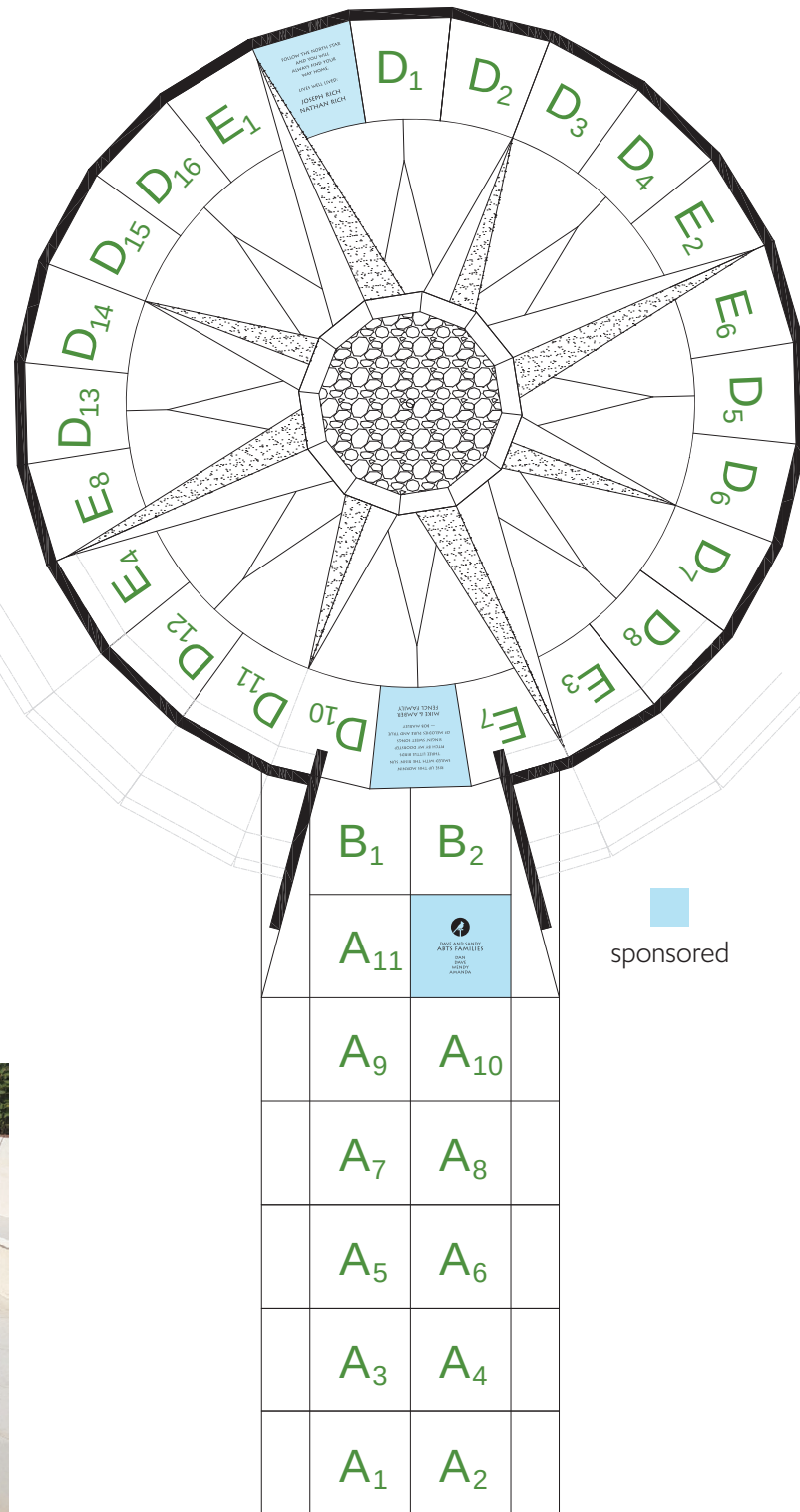
The Council Circle is a landscape feature celebrated by Midwest landscape architect Jens Jensen. Its origins trace back to Indigenous American cultures.

The uniquely particular installation at Van der Brohe Arboretum & Bird Sanctuary is incised into sloped terrain, allowing for a vista over the tranquil grounds.

The pavement is configured as a compass rose composed of locally quarried Valders limestone with Bluestone highlights. Inscribed sun angles for the solstices and equinoxes are to be added.

Sponsorship of the pavement stones is a wonderful form of commemoration. The Circle itself was funded by George Grimm, formerly of Two Creeks, in honor of his wife Susan.
